During occupancy of the leased premises, the Tenant shall ensure that the grooms shall maintain the premises in a clean and tidy manner and shall exercise such control of these grooms by conformance with written rules of conduct as may be required to maintain a well-behaved and orderly situation at all times. A copy of this "Dormitory Agreement" setting forth the rules of conduct and conditions of occupancy are attached and made a part of this Agreement.

- 3. Facilities: The Landlord agrees to provide the leased rooms consistent with the accourrements found in a standard motel room operated by the Landlord. This shall include electric, heat, air-conditioning, hot and cold running water, the appropriate number of beds, sheets, pillow cases, pillows, blankets, within a room capable of being secured, together with sufficient keys for the occupants. The Landlord shall provide cable TV service without charge, weekly maid service to clean the room and change the sheets and pillow cases on the provided beds.
- 4. <u>Subletting Assignment:</u> The Tenant agrees not to assign or sublet any part of the demises premises unless the Landlord agrees in writing and Landlord will not unreasonably withhold consent to an assignment or sublease on good cause given. Tenant will provide Landlord a weekly list of the individuals authorized to reside at Landlord's facility as needed.
- Damage and Destruction: Should the premises be destroyed or injured by the elements or for any cause so as to be untenable and unfit for Tenant's business, the Tenant may

quit and surrender possession of the premises. The Tenant shall not be liable for any rent under this lease for any time subsequent to the destruction or damage

to the building. In the event that the Landlord elects to rebuild the demised premises, the Landlord will commence reconstruction within thirty (30) days of when the damage occurred and shall continue to continually repair the building until it is tenable for the use of Tenant's business. The Tenant, at his option, may then occupy the building and the rent shall be suspended from the date of loss until the date the Tenant reenters the premises as tenable for Tenant's business. Should the premises be partially destroyed or damaged by fire, explosion or the elements, and should the Tenant, at its option, elect to remain in possession of part of the damaged premises, then, in that event, the rental shall be abated and adjusted on a square foot basis, the Tenant paying on a square foot basis based on the annual rental t the date of loss for that portion of the premises in which it remains in possession. Should the Tenant elect to remain in possession, the owner shall, subject to the rights of any mortgagee, repair the premises by commencing repairs no later than thirty (30) days after the loss or damage and continuing repairs until they are completed. Should the Tenant elect to remove from the premises in case the demised premises are partially damaged by fire, explosion or the elements, the Tenant shall not be liable for any rental under this Agreement for any time subsequent to the destruction or damage of the building.

- 6. Fixtures: All trade fixtures installed by the Tenant or the groom's occupants shall remain the property of the Tenant or the groom's occupants and may be removed any time during the period of the lease. Upon termination of this lease, the Tenant, and/or groom-occupants at its option, may remove all such fixtures or abandon them in place. Fixtures left abandoned in place after the termination or expiration of this lease shall become the property of the Landlord. All remodeling and improvements made by the Tenant and/or groom-occupants remain the property of the Tenant and may, at the Tenant's option, be abandoned in place or removed. The Tenant agrees that any improvements placed on the premises shall be removed without damage to the freehold, or the premises shall be repaired.
- 7. Condemnation: In the event that all of the leased premises shall be taken in condemnation proceedings, this lease shall terminate as of the date of title vesting in the condemning authority and all unearned rental and other charges paid in advance shall be refunded to Tenant and Tenant shall surrender possession of the leased premises to the condemning authority subject, however, to the rights of the Tenant to remain a tenant in possession under Federal or State laws which the premises are condemned and further subject to the rights of the Tenant to any relocation costs or other profits accruing to Tenant in possession




