Mr. Kiedrowski informed members of numerous thank you notes, they include Junior Achievement of WNY, Inc., Genesee Business/Education Alliance, Volunteers for Animals, Louis J. Billittier Foundation, St. Paul's Episcopal Church, Goshen Historic Track, Mount St. Mary Academy, The 11 Day Power Play, Cornell Cooperative Extension Leadership Genesee, and Suny GCC.

Mr. Ryan Hasenauer, Director of Marketing, presented photos from past Batavia Downs Concert Series events that included Almost Queen, Get the Led Out, Craig Morgan, Marshal Tucker, and Great White.

Mr. William R. White, Vice-President briefly discussed a need for an increase to the Security Guard wages. The department continues to update corporate policies.

Mrs. Jacquelyne A. Leach reviewed the June 2023 Chief Financial Officer Reports with Committee members. Mrs. Leach discussed the results of operations for branches and Batavia Downs. The Corporation will distribute \$55,194 in surcharge revenues to member municipalities for June. For the second quarter 2023 the Corporation will distribute \$2,527,528 in operational earnings to member municipalities.

Mrs. Leach reviewed the Regional VGM Numbers with Board members, highlighting Batavia Downs Gaming net win performance through June as compared to same period 2023 and 2022.

Ms. Dina Pane, General Manager of OTB Operations briefly discussed the Phoenix Branch closing on Saturday July 29. There are nine (9) branches and twenty-seven (27) EZ-Bet locations.

Mr. Wojtaszek led a brief Insurance discussion that included research into employee health care options in the future.

Mr. Sean S. Schiano, Vice President - Operations provided gaming floor statistics.


